Position summary

The purpose of this contract position will be to provide staff with external clinical supervision and EAP services to nominated staff at Grampians Community Health.

Key responsibilities

1. Provide clinical supervision and support to staff and students as required in accordance with Grampians Community Health supervision policies and associated procedures.
2. Assist staff to prevent or resolve personal, family and workplace problems affecting their wellbeing and job performance through the EAP program.
3. Use specialist professional knowledge and advanced practice skills to assist staff with complex clinical work.
4. Promote evidence based clinical practice to all staff through supervision.
5. Provide constructive feedback to staff including strengths, professional development needs and opportunities.
6. Support the relationship between staff and consumers to ensure optimal outcomes for both.
7. Promote choice, empowerment, independence, wellness and enablement within the delivery of consumer focussed care.
8. Fulfil duty of care responsibilities as outlined in Grampians Community Health policies Supervision and Support Policy
9. Promote Grampians Community Health's mission and values to GCH staff
10. Communicate effectively and regularly with general management by regularly reporting, relating clinical reviews of staff
